Query by Terry Lewin as to the status of remediation of Dams.

Mr Wright advised that repairs are being coordinated by the MSB with the view to completing prior to Christmas.

8. COMMUNITY REPRESENTATIVE QUESTIONS/COMMENTS

Mr A Brown spoke of the reduction of the workforce and the previous discussion of the last meeting with Mr Gibson regarding the Longwall presentation and asked if the mine had proceeded with the Longwall project.

Mr McGuigan advised that the progress on the review has been slow but due to the economic benefits, the Longwall project review is progressing. He advised that if there is justification, then further work will be done including consultation and required studies. Whilst no decision has been made at this stage, Donaldson is continuing the evaluation process. The Feasibility Stage will address subsidence.

Mr Jennings asked if the Budget has been submitted based on Bord & Pillar.

Mr McGuigan advised that the 2016 Budget has been submitted on Board & Pillar as any Longwall project will have a timeframe of greater than one (1) year.

Mr Jennings asked if 2016 is based on the current situation.

Mr McGuigan advised that there were various scenarios put forward including the current situation.

Mr Alan Brown questioned the statement by Independent Environmental Auditor– that are you or are you not compliant – how does the consultant determine compliance? Is 99% compliant?

For example, on Page 7 - Subsidence and compliance plan satisfactory and ongoing.

Mr P Brown advised that Donaldson will request a response from the Auditor.

Mr Lewin commented that compliance will have a range.

Mr A Brown requested as to which is the prediction and which is the actual Column in Table 4.5.3A. Mr P Brown advised that a response will be provided by the Auditor.

Mr A Brown requested clarification on page 19 and included tables of what range is deemed acceptable to determine Compliance and Non Compliance

Mr A Brown asked if Donaldson pumps water out from the Abel Mine.

Mr P Brown advised that water is pumped from underground to the Big Kahuna and then pumped to Bloomfield for use in the Coal Handling and Preparation Plant as per the Abel Water Management Plan.

Mr A Brown commented on the quality results included in table 4.7.6.4 – general comment on the difference in the result and if there is any concern from a mine site.

Mr A McGuigan advised that the results were in line with what has been experienced previously.

Mr A Brown advised that the Compliance Table states that it is 2014 included instead of 2015 - Reponses Consultant to update documents
